Policy and Governance

Selicia Douglas continued for a third year as Director of Policy and Governance overseeing development of key chapter and board policies following completion and approval of the Chapters' updated Bylaws.

Membership and Volunteering

- In 2019 the Chapter met its goal early for 75% member retention and we increased in membership by 7.45% reaching 693 members. PMP credentials remain the highest percentage of credentials held but we are seeing an increase in the other credentials PMI has to offer including ACP (up to 14 now).
- PMI Nova Scotia currently has 64 volunteers from Board members to mentors, study group facilitators, and committee members including events, communications, etc.
